### 2 SNOMED CT

It has been brought to our attention that as a result of being uplifted to the international edition of SNOMED CT, the following code used within Data Item 18 (Is main carer aware of person's prognosis) on page 67 of the Requirements Specification has been superseded.

751961000000104 | Relative aware of prognosis (situation) |

has been replaced with:

473316003 | Relative aware of prognosis |

If you are using a health IT system which includes SNOMED CT codes according to licence, this will have little impact. Other non-standard uses of SNOMED CT may introduce a risk of failure to correctly share the value of this data item and you should seek advice from the Clinical Terminology team at the HSCIC - information.standards@hscic.gov.uk

### 3 NHS England statement

NHS England has provided clarification around the sharing of information which this standard promotes. This follows enquiries from implementers which have indicated some confusion about Section 3.1 (IT system suppliers) of the requirements specification. NHS England would like to make it clear that the standard is designed to achieve interoperability. As a result, there is the expectation that in implementing the standard, solutions will provide the ability through open structured interfaces (open APIs) for access to and notifications of update to the end of life preferences. This facilitates the sharing of information across multiple systems and multiple care providers to support the care co-ordination process.
